THE HEBREW FREE BURIAL ASSOCIATION was formed in 1888 on Manhattan's Lower East Side by a group of philanthropic and community-minded Jews who were committed to burying their indigent dead according to Jewish tradition, rather than having them buried in a mass grave in Potter's Field. Since its inception HFBA has interred nearly 60,000 Jews in its two cemeteries. HFBA is also committed to retrieving the identities of those interred and is attempting to provide a gravestone for each unmarked grave.

THOUGHTS FOR THE NEW YEAR

Many people consider the highlight of the *Rosh Hashana* and *Yom Kippur* services to be the very moving prayer, *Unesaneh Tokef*.

Unesaneh Tokef reminds us of our mortality and of the unpredictability of life and living. We reflect on the past and look forward, with trepidation, to the future. We think of those who may have perished by flood, disease, starvation or storm, calamities which are still all too common in our global community.



The powerful poetry of this prayer includes beautiful imagery and forceful metaphors and contrasts. Our G-d is a powerful king and caring shepherd. The great sound of the *shofar* will ring and a small, still voice will be heard. Some will experience calm, others, turbulence. Some will have strength and vigor, others pain and suffering. The fortunate will die in peace at their given time; the unfortunate will die too young or after prolonged affliction.

As we stand before the Almighty being judged, let each of us commit to repairing the very broken world in which we live. Let us promise ourselves to do our part in *tikkun olam*. Let us honor our Creator by treating all of His creations with integrity, honesty, dignity and respect, for the living as well as the dead.

HONOR AND RESPECT FOR THOSE WE REMEMBER

VISITING THE CEMETERY

Walking through HFBA's Silver Lake and Mount Richmond cemeteries, with their thousands of unmarked graves dating from 1892, one is saddened by thoughts of children who never grew up, of teenaged victims of the Triangle Shirtwaist Factory Fire who never grew old. One can feel the spirits and imagine the misfortunes of immigrants who were unable to live the "American dream" in the *goldeneh medineh*, and those who died alone and forgotten as victims of physical and mental illness, homelessness and destitution.

During the month of *Elul*, preceding the High Holy Days, our thoughts turn not only to our own mortality, but also to those whom we have lost. A common custom is to visit the graves of our ancestors and loved ones. We pay our respects, mourn their passing and acknowledge their impact on our lives. We are able to imagine history and destiny.

Since its inception, HFBA has buried over 60,000 people. In each of the past several years, burials have averaged approximately 250, a significant percentage of those being immigrants from the former Soviet Union. During the 1990's at the height of the Russian immigration to the United States, at that time 75% of the 400 funerals performed yearly were for Russians. Currently, nearly 1,000 mourners crowd Mount Richmond each Sunday during the weeks preceding *Rosh Hashana* to embrace the memory of the departed members of this recent immigrant community.

RECITING THE KADDISH

An important custom associated with the *yahrzeit*, the anniversary of a death, is the recitation of the



kaddish, the prayer which glorifies the Almighty and His attributes. There is a widely held belief in traditional Judaism that reciting the *kaddish* with a *minyan* (quorum of ten men) in some way elevates the soul of the deceased through the glorification of G-d by the living.

If a relative is unable to say the *kaddish* at the appointed time, it is customary to arrange for it to be said by another. For a donation of \$180, HFBA will arrange for *kaddish* to be said every year on the *yahrzeit*, **regardless of whether or not the final resting place is at one of HFBA's cemeteries.**

Please contact the HFBA office at (212) 239-1662 to establish a "perpetual kaddish" (one said on the yearly anniversary). Alternatively, send \$180 along with your request and information about the deceased (including exact Hebrew name and Hebrew name of the decedent's father as well as the date of death) to the HFBA office in the enclosed envelope. Please include your telephone number.

MARKING GRAVES

Especially after the Holocaust, the idea of leaving a grave unmarked seems insensitive and cruel. In 1987, HFBA initiated the Leave Your Mark Campaign to begin marking all graves, inscribing the name and the dates of birth and death of each

HFBA HELPS

Some of our referrals are from the NYC Medical Examiner's Office or from the offices of the Public Administrator of each borough. Referrals also come from hospitals, nursing homes or other care facilities. Despite the fact that approximately 75% come from family members, neighbors or friends, there are no mourners at one third of our burials. HFBA chaplain Rabbi Shmuel Plafker stands alone at the grave.



Mrs. Rapp, an elderly woman who had been ill for some time, died and her body was picked up by a local Jewish funeral parlor. After determining that the family could not afford the fee, and after it was revealed that the District Attorney had a long-

standing investigation of elder abuse against her aide, Mrs. Rapp's remains were retrieved by the Medical Examiner, posthumously examined for signs of abuse and finally released to HFBA for burial.

A call came in to the HFBA office regarding a woman's body which had been in the morgue for four months. Her much younger husband was unconcerned and claimed that he did not know how to have her buried without expenditure. HFBA was able to convince him to release the body for burial. After consenting, he disappeared without attending the funeral or having any other contact with HFBA.

Mrs. Samuels was buried by HFBA while her husband was in a care facility with advanced Alzheimer's disease, unaware of her death. Six months later, Mr. Samuels' burial was also performed by HFBA. Their entire family of several generations rests in HFBA's Mount Richmond Cemetery.

decendent. On a regular basis, Rabbi Shmuel Plafker, HFBA's chaplain, walks through specific sections of Mount Richmond Cemetery, making note of each grave lacking identification. Extensive archival work done in our office follows. Much time is spent researching hand written records to match an individual with a particular gravesite.



HFBA has been able to mark all gravesites at Mount Richmond Cemetery for deaths occurring up until 1990. Through the generosity of HFBA supporters, over 300 graves received markers in the last year. A future campaign will be initiated to purchase markers for the thousands of unmarked or illegibly identified graves at our historic Silver Lake Cemetery.

РУССКИЙ ДАЙДЖЕСТ

Молитва Кадиш

Готовщина смерти - *Йорцайт* - это особое время, когда душа покойного имеет особо сильную связь с родственниками. В *Йорцайт* отдают дань памяти умершего, вспоминают о нём и размышляют над сущностью его жизни. В этот день принято читать молитву *Кадиш*, буквально - "освящение", обязательно в присутствии миньяна (кворума из 10 совершеннолетних мужчин). Еврейская традиция нам говорит, что прославление живущими святости и величия Всевышнего возвышает душу покойного в будущем мире.

Если у родственников нет возможности в день *Йорцайт* самим прочесть *Кадиш*, то обычай предписывает позаботиться о его прочтении другими людьми. **Пожертвование на сумму 180 долларов** гарантирует организацию Еврейским Благотворительным Похоронным Обществом HFBA «Вечного Кадиша» - ежегодного чтения молитвы *Кадиш* в *Йорцайт*, **не зависимо от того, покоится ли близкий Вам человек на одном из наших кладбищ.**

Пожалуйста звоните нам по телефону **(212) 239-1662** чтобы заказать «Вечный Кадиш». Также Вы можете прислать пожертворание по почте, с указанием даты и времени смерти, еврейского имени покойного и еврейского имени его отца. Установление «Вечного Кадиша» предоставит Вам возможность не только почтить память близких, но и исполнить высочайшую *мицву* - помочь с достоинством проводить в последний путь малоимущих согласно еврейской традиции.
