Since its inception HFBA has interred nearly 60,000 Jews in its two cemeteries. HFBA is also committed to retrieving the identities of those interred and is attempting to provide a gravestone for each unmarked grave.

FROM OUR FILES...

The HFBA staff is often called upon to undertake unusual tasks associated with Jewish burials. The following stories illustrate both our detective skills and investigative limitations!

S ome months ago, while repairing a retaining wall in Silver Lake Cemetery, construction workers came upon a partial headstone from 1911. The HFBA office staff finally deciphered the name of an 11-year old girl, Tillie (*pseudonym.*) Using the extensive HFBA records, as well as online ship manifests from a century ago, HFBA determined that Tillie had come to the United States with her mother and four siblings and had died suddenly. Her father had applied for the HFBA burial.

Although it is now known to whom the gravestone belonged, it is still a mystery as to how this headstone came to Silver Lake Cemetery, as HFBA stopped burying its clients there in 1909. HFBA ultimately recovered Tillie's actual grave in Mount Richmond Cemetery next to the unmarked grave of her 2-year old sister who tragically died several months after Tillie. Through the HFBA Leave Your Mark Campaign, both sisters received new gravestones. Tillie's original, partial gravestone was rested on her grave as well.

Al died in his Queens apartment and was taken to the medical examiner's office. His landlord had called us but we were unable

friend could not name the dentist, other than to recall that his office was on Jewel Avenue in Flushing. The dedicated HFBA office staff called every dentist in that area and finally located Al's dentist who sent the dental records to the medical examiner. Al was identified, his remains released and he was buried in Mt. Richmond Cemetery.

Dear Friends at the HFBA,

On behalf of my students and my school, Solomon Schechter School of Westchester, I wanted to thank you again for your help in planning our visits to your Silver Lake and Mount Richmond Cemeteries last year.

It has become a school tradition for our freshmen and senior classes to each spend a day at the beginning of the school year helping with maintenance and learning about *'chesed shel emet'* at the Silver Lake Cemetery. Each year, I have been impressed by the sensitive way your staff introduce the students to the meaningful work they will be doing, and by my students' excitement and eagerness to help keep the cemetery grounds clear and well maintained. I particularly love the way visiting the HFBA cemetery brings the kids together to fulfill such an important Mitzvah.

Last year, though, our visit was not only a great experience in and of itself, but created an opening for an even more meaningful return trip. When Andrew Parver, Director of Education and Outreach, explained that the vast majority of burials at Mount Richmond are done without family members in attendance, without a *minyan*, and without even *kaddish* being recited - that struck a chord with my students. Then and there, they decided to do what they could to make a difference, committing to attend and provide a *minyan* for an otherwise anonymous burial the coming spring.

Fall gradually became winter, winter eventually yielded to spring, and eight months after their initial visit to Silver Lake, our seniors were once again on their way to Staten Island - this time to Mount Richmond to fulfill their pledge from the beginning of the year. An elderly woman who had outlived her family and savings had passed away the day before and the HFBA was doing its part to make sure she was provided with a proper Jewish burial. My students did their part as well, providing a *minyan* and making sure that even if this woman had died penniless, she would not be buried anonymously.

HFBA's mission of 'chesed shel emet' in providing for Jews who have passed away is incredibly important, but in thanking you, I want to also salute all that you do to transmit values and educate the Jewish community. You not only have an impact on *Olam HaBa*, you have a huge impact on *Olam HaZeh*. On behalf of myself and my students, thank you.

DESIGNATING "POWERS OF ATTORNEY"

power of attorney is a legal instrument allowing a "principal" to delegate legal authority to an "agent" to make property, financial and other legal decisions. It is most often used in the event of illness or disability when one is unable to sign necessary legal documents.

A *durable power of attorney* enables the agent to act for the principal immediately, regardless of whether the principal is mentally competent or physically able to make decisions. It may be revoked by the principal at any time. A springing power of attorney becomes effective at a future time, frequently when the principal's physician determines that the principal is unable to handle his or her financial affairs. It remains in effect until the principal's death or until it is revoked by the court.

It is a good idea to plan for your future to the extent that it is possible. The forms to effect the terms described above may be obtained from legal stationers and office supply stores. The forms must be notarized.

РУССКИЙ ДАЙДЖЕСТ

Ханука 2008

Из нашей картотеки...

Служащие HFBA часто решают нетривиальные проблемы, связанные с еврейским погребением. Нижеизложенные примеры из повседневной жизни компании иллюстрируют смекалку и незаурядные детективные способности наших работников.

 Несколько месяцев назад, во время ремонта несущей стены на кладбище Silver Lake, рабочие обнаружили часть памятника. Служащие НFBA расшифровали имя 11–летней девочки, Тиллии Д. (псевдоним), умершей в 1911году. С помощью обширной картотеки, а также портовосудовой декларации, заполненной сто лет назад, работники HFBA выяснили, что Тиллия приехала в США с мамой и 4-мя братьями и сестрами, но внезапно умерла.

Несмотря на то, что стало известно кому принадлежит памятник, как он оказался на кладбище Silver Lake остается загадкой. Во- первых, кладбище Silver Lake было закрыто для погребений в 1909 году, до смерти Тиллии. Во вторых, работники HFBA в конце концов обнаружили могилу Тиллии на кладбище Mount Richmond, рядом с могилой (без памятника) ее 2-х летней сестры. Обеим сестрам были установлены новые памятники благодаря компании"Leave your Mark", проводимой HFBA. Найденную на кладбище Silver Lake часть первого памятника Тиллии, также отреставрировали и установили на ее могиле.

 Когда Ал С. скоропостижно скончался в своей квартире в Квинсе, нам позвонил хозяин дома. Для установления личности тело покойного взяли на медицинскую экспертизу. Друг Ала посоветовал нам связаться с зубным врачом покойного, офис которого находился на Jewel Avenue во Flushing. Преданные своему делу работники HFBA обзвонили все зубные кабинеты района и нашли врача, который предоставил необходимую информацию для медицинской экспертизы. В результате мистер С. был похоронен на кладбище Mount Richmond согласно еврейской традиции.

Размышления о Хануке

А знаете ли Вы? Назначение "Power of Attorney"

Power of Attorney* – это инструмент, которым человек (доверитель) назначает другое лицо (агента) решать за него разные юридические проблемы, в том числе связанные с вопросами финансов и собственности. Такое назначение часто используется в случае болезни или инвалидности, когда человек не в состоянии подписать юридический документ.

Рассчитанный на долгий срок Power of Attorney дает возможность агенту действовать за доверителя и в том случае, если последний не в состоянии принимать решения в связи с умственным или психическим расстройством. Можно сделать назначение, которое станет действительным в будущем, при наступлении каких-либо обстоятельств. Например, если в будущем врачом будет установлено, что лицо не в состоянии вести свои финансовые дела. Power of Attorney имеет юридическую силу до момента смерти доверителя, однако, может быть отменено в любое время доверителем или по решению суда.

Это неплохая идея заранее предусматривать все непредвиденные обстоятельства в будущем. Формы для заполнения вышеописанного документа Вы можете приобрести в отделе форм в магазинах, где продаются канцелярские товары. Документ Power of Attorney обязательно должен подписан доверителем и заверен нотариусом.
