Dear Supporter,

As I think about 2012, my first thought is the number of people we served. Following the trend, the demand for our services continued at a record-breaking pace. Certainly, more and more Jews are dying in poverty and alone, and we were able to provide funerals and burials for nearly 400 – and offer care and supportive services to their survivors.

This work is about people, of all kinds and from all walks of life, and by that I also mean you and me. Your gift supports the daily work of our dedicated staff who provide compassionate care at the end of life. I wish I could tell you stories of all the lives we touched

in 2012 and what deep gratitude surviving friends and family expressed. Please know that your

generosity reached people in very trying circumstances, with nowhere else to turn, and provided comfort and hope.

Our Volunteer Program also continued to grow, attracting diverse groups, including students from West Point, to our clean-up days at Silver Lake Cemetery. Many are surprised by the moving experience of visiting this sacred, historic site. I'm also humbled to report that volunteers, mainly from Staten Island, provided minyans for 90% of our funerals, even on the chilliest and most sweltering days. We owe a debt of gratitude to these dedicated volunteers.

The restoration of Silver Lake Cemetery began officially in 2012, when we hired Elizabeth Kennedy Landscape Architect to serve as project manager and finalize the investigations and assessments necessary to move forward the much-

needed rehabilitation of the 121-year-old cemetery. The project attracted one very generous donor who allowed us to meet our year-one goals. Thank you!

We also saw old friends and connected with new donors at Breakfasts in both Riverdale and Staten Island, and one of our board members, Gary Katz, hosted a parlor meeting at his home in White Plains. Our outreach and education also included two articles published in the Huffington Post, as well as a conference we hosted for the Jewish Cemetery Association of North America, attracting 50 colleagues from across the U.S. and Canada.

Like many other New York City non-profits, any discussion of 2012 could not omit the turmoil and grace under fire we witnessed as a result of Hurricane Sandy. Thank you to our staff and donors for helping persevere under extremely difficult circumstances.


