Lev Echad (One Heart) Beating Strongly At HFBA

Prevailing "wisdom" has it that young people are too involved in planning their own lives to be interested in the deaths of the anonymous poor. A group of committed New Yorkers, under the leadership of HFBA board member David Danzer, has proven the adage wrong by forming a young leadership group dedicated to supporting the Hebrew Free Burial Association.

The goal of *Lev Echad* (One Heart) is to raise awareness of the work of HFBA and to organize the next generation of lay leadership for the organization. he end of the year is almost upon us and if you are like many of your fellow citizens, you are wondering how much Uncle Sam will take out of your hard-earned savings. Many people have benefited from the fluctuating market in the past year, and some will find themselves taxed on sizable appreciation in securities.

By transferring a portion of appreciated stock to HFBA, you can lower your tax burden and help ensure that poor Jews can be buried with dignity at the same time. You will then have the benefit of a charitable deduction and avoid capital gains tax on the stock that is transferred.

Donors who are planning retirement strategies or seeking ways to maximize income during their senior years should keep this tax strategy in mind. Appreciated stock can be used to set up a charitable trust or annuity that can generate tax free income for the donor for the duration of his or her retirement. Following death, HFBA will receive any funds remaining in the trust or the principle of the annuity, relieving your heirs

filling your desire to remember HFBA. With today's market at an alltime high, this is a great opportunity to realize your gains and prepare for the future at the



The procedure is relatively simple. Suppose you bought a stock for \$1.00 that is now selling at \$10. For every share you donate, you get a charitable deduction worth the full \$10 (the current price, not the original cost). By contributing appreciated stock, you are giving a gift worth far in excess of the price you paid. In addition, you get all the normal tax advantages of a cash gift, plus the extra bonus of avoiding capital gains taxes for the donated stock. Thus, your gift costs you less than if you had sent us a check for the same amount — but the value to HFBA remains the same!

Remember that no stock can be transferred without your express permission to your broker or investment manager. Stock transfers are electronic and the paperwork for trusts and annuities is straightforward and simple. Hundreds are Leaving Their Mark At Mt. Richmond Cemetery This Fall



hanks to a special appeal during our annual Rosh Hashana campaign this year, the graves of hundreds of indigent Jews that were previously unmarked will receive stone markers through our LEAVE YOUR MARK campaign.

"Our supporters have once again been extremely generous in their responses," affirmed board member Howard Wallick. Almost 100 additional monuments can be purchased as a result of the appeal."

Many new participants; others add to previous commitments

The Rosh Hashana campaign was particularly successful in encouraging participation among those who had not previously considered contributing to LEAVE YOUR MARK. Additionally, several past participants took this opportunity to increase their commitment, sponsoring one or more additional monuments. Since the campaign began, many names have been added to the LEAVE YOUR MARK Donor Plaque in Mt. Richmond Cemetery, which is inscribed with the names of


those who have donated a minimum of four markers. Plaques can be inscribed in memory or in honor of a loved one in perpetuity.

Loved Ones Remembered Through Participation

It has become a common practice among participants to request that monuments be sponsored in memory of a beloved relative or friend. This year, many chose to donate in conjunction with their annual Yom Kippur *yizkor* pledge, choosing HFBA as the beneficiary of their magnanimity. The Tragedy of TWA Flight 800 propelled one contributor; although many on that flight might never be interred in marked graves, the donor ensured that an indigent Jew would no longer suffer that fate.

"When we initially began the effort to mark every grave in Mt. Richmond Cemetery, there were some who thought the job was too big and could never be accomplished. With the help of our new and continuing friends, LEAVE YOUR MARK will continue to move forward towards our goal," concluded Mr. Wallick.


