Additional 500 Markers Arriving This Spring

The graves of 500 indigent Jews buried in Mt. Richmond Cemetery will be marked by simple stones as the LEAVE YOUR MARK Campaign continues to transform the look of Mt. Richmond.

Instead of empty-looking fields, the grass of the cemetery is now studded with rows of low markers, each inscribed with the name and years of life of the person buried beneath. The monuments are a moving testimony both to the lives of the deceased and the dedication of HFBA friends and supporters determined to remember them.

Men's Section Gets 250 Markers

Among the sectors which will be enriched by the monuments this Spring is a section of men who were buried between 1944 and 1953. They ranged in age from 14 to 89.

The youngest person in this section is a boy of 14 who was abandoned by his parents and left at the Willowbrook State Facility for the Retarded. (In those days, the parents of children born mentally retarded were sometimes so traumatized by their children's conditions that they were sent to live their lives in institutions for the retarded.) When he died at 14, his parents wanted no involvement in the funeral arrangements and the sad task was left to his grandparents. Willowbrook was able to put them in contact with the HFBA. While they authorized his burial in Mt. Richmond Cemetery, his grave has remained

FROM THE PRESIDENT'S DESK HFBA Gains/Important Status as New York State Referral Agency

ur tradition emphatically tells us that the reward of performing a mitzvah is the mitzvah itself, not the rec-

ognition we receive. However, there are in-

stances when public recognition is crucial, as we recently found out.

The New York State Department of Health announced that the Hebrew Free Burial Association is listed in the resource guide given to all health and social services agencies as an appropriate referral source for burials of indigent Jews. Simply stated, it means that when an in-

digent Jew passes away in a hospital, nursing home, State-run facility or even at home, the appropriate authority may contact us regarding the funeral arrangements.

The practical result of the pronouncement has been an increase in phone calls from

agencies dealing with the Jewish poor both upstate and downstate. When it is not feasible to arrange for the funeral and burial to be performed at Mt. Richmond Cemetery, we are able to refer the caller to a *chevra kadisha* (burial society) in

their area to ensure that the interment is carried out in accordance with Jewish tradition. Our involvement also ensures that the deceased is not buried in a Potter's Field or in a non-Jewish cemetery.



Dear Cousin:

Just a short time before the High Holidays I visited my Zaida's grave at Mt. Richmond Cemetery in Statin Island. For those cousins who don't know it, my grandfather, Max Cooper died in October of 1937, a time when all the family was desperately poor. Zaida had not arranged for his burial, something that many Jewish people did at that time. The family did not have enough money to bury him, and he was buried at little or no cost by the Hebrew Free Burial Association. Apparently, the family did accumulate enough money for a grave marker, and Zaida does have a stone marking his grave.

When I went to the cemetery, I learned that a large percentage of Jewish people buried at Mt Richmond Cemetery have unmarked graves. There is a drive at present to collect money to mark these graves, people who died during a large flu empedemic, women who died in the Triagle fire, 50 children who died at the Willowbrook State School for the mentally retarded. Each marker is \$150.

I think that it would be a charitable gesture for all the cousins at the Cooper Family Circle to contribute \$5.00 each so that if 30 of us do this we would have one marker as a family to pay back in a small way what the Hebrew Free Burial Association did for my grandfather back in October of 1937. If you agree, when you come to the Family Circle Meeting October 13 1996, please bring your \$5.00 check made out to HEBREW FREE BURIAL ASSOCIATION. I will send them to 363 -7th Avenue, New York, NY 10001. If we don't get enough, I will make up the difference; if we get more than \$150, the contribution of the difference can go to poor people being buried at this time; people who don't have enough for their own burials, for their own markers, and people who don't even have one person at their funerals.

Zaida's grave is being kept up nicely at the moment. I have even arranged to have few plantings for his grave.

We are ver lucky to have our own cemetery grounds at Wellwood. And we are lucky to have each other who care both in life and death. The HEBREW FREE BURIAL ASSOCIATION takes care of those who don't have family, friends, or money.



Howard, who would have been 61 had he lived, will finally have a memorial to his brief life, erected by friends he never met.

Excellent Response Leads To New Projections

While the original plan was to purchase monuments annually, the large numbers which

have been ordered as LEAVE YOUR MARK gains momentum necessitated a change in plans. According to HFBA president Gerald E. Feldhamer, stones will now be bought and set twice annually.

"The response has been terrific," stated Bjorn Bamberger, HFBA vice president. We are looking forward to doubling this year's this year's total and installing 1,000 monuments next year."

INTEREST IN HFBA YAHRZEIT PROGRAM GROWS

Interest in the HFBA's projected Yahrzeit Notification Service has been substantial, but not great enough to warrant the purchase of the computer software necessary to implement the program at the present time, board member Jack Weiss, announced recently.

"We conceived the program in response to a number of requests from our supporters who have friends and family buried in our cemeteries," he said. "However, in order to make Yahrzeit notification costeffective for a small agency like ours, we are offering the service to all our donors as well." The service would provide a timely reminder of both the Hebrew and English dates of the anniversary of the death of a loved one. The deceased does not have to be buried in Mt. Richmond Cemetery.
