How to Make Your Last Wishes Known

None of us like to think of our eventual death. We may have bought our plots and taken care of all arrangements. Still, it's not easy to discuss our desires with family and friends. And for those among us who are truly alone – the very elderly, those who are bereft – perhaps there isn't even anyone to tell.

Communicating our last wishes is never easy – but remaining silent can make it much more difficult for everyone. In the worst case, we may be denied the right to a Jewish burial:

Molly died alone, at home. She had been a very private person and had never discussed her religion – or her end-of-life plans – with anyone. It was only her last name that hinted to her Jewishness. If the Public Administrator's office had not called the Hebrew Free Burial Association, Molly would have been buried at City Cemetery.

Here are some simple steps that you can take, to ensure that your wishes are known:

- Write your wishes down (see page 2 for a sample set of directions).
- Include the name and phone number of your rabbi and location of your burial plot. If you've already paid for your plot, attach the receipt or indicate where it can be found.
- Keep a copy of these instructions separate from your will. They should be easily accessible in your home and with your other important papers.
- Discuss your wishes with a relative or friend or with your rabbi.



When we set down our instructions, we make sure that our funerals conform to our beliefs and that we are buried near family, friends or community.

But how do we ensure this final dignity for the elderly and indigent who have been left in nursing homes? Some sink into debilitating illness and are no longer able to express themselves. Perhaps they live in a care center where no one has ever asked them about their wishes.

To ensure a Jewish burial for every Jew, HFBA reaches out to nursing homes across the city. Our task is to ask questions: Do you have any Jewish patients? Have you marked down their religious preferences? Do you know if they already have burial plots? Have they affirmed that they don't want cremation?

Your support of HFBA ensures that every Jew – no matter his or her circumstances – is buried according to Jewish tradition. We are so grateful for your support and wish you a long and happy life.

HFBA Helps

Olga, an unemployed drug addict and alcoholic, died at the age of 41 after years of depending on public assistance and Medicaid. She had a non-Jewish "green card" husband who wanted nothing to do with her burial. Fortunately, HFBA found her sister who authorized the burial. With the volunteer *minyan* in attendance, Olga's 11-year old daughter stood tearfully at her mother's grave.

Boris was 81 years old when he died. In better times, he had been an accomplished journalist. HFBA was notified of his death by a friend two months after he passed away. The friend informed us that Boris' brother, Igor, was ill and impoverished and could not contribute funds towards the burial. Igor, however, reached out to Boris' estranged wife and his to his daughter, Katya. Katya, distraught over the loss of her father and adamant that he be buried as a Jew, called HFBA. She told us that she had a falling out with her father and had not seen him

for two years. As an unemployed, single mother on food stamps and Medicaid, she nonetheless worked with HFBA, authorizing and contributing to the costs of the burial. At the service, attended by family and friends, Katya tearfully shared her feelings that Boris had been a devoted father, brother and grandfather.

In September, HFBA was called by the Medical Examiner (M.E.) about 46-year old **Victor**, who had died as a result of a drug overdose. The decedent's landlord had informed us that the decedent was a Jewish man, wearing a *kippah* and displaying a *mezuzah* at the door of his apartment. HFBA notified the Public Administrator who already knew about the case and shared with us that the decedent's Social Security number matched two people, a woman, Sabrina and a man, Victor. At this point, our staff realized that the individual was transgender.

As a Jew, Victor was entitled to a Jewish burial which he received in our cemetery. The members of the volunteer *minyan* attended Victor's burial so *kaddish* could be recited. There were no family members or friends at his funeral.

Names and details were changed to protect confidentiality.

Чтобы наша последняя воля была известна

Мало кто из нас по-настоящему задумывается о неизбежной кончине. Возможно мы приобрели участок на кладбище и прошли связанные с этим формальности. Тем не менее довольно трудно обсуждать нашу последнюю волю с близкими или друзьями. А тем из нас, кто по-настоящему одинок - глубоким старикам, тем, у кого не осталось близких, – зачастую бывает просто не с кем обсудить свои пожелания по поводу похорон и погребения.

Но хотя обсуждать последнюю волю нелегко, умалчивание о ней создаёт трудности для всех. В худшем случае человек может даже лишиться права на погребение по еврейскому обряду. Вот несколько шагов, которые Вы можете сделать, чтобы ваша последняя воля была известна:

- Запишите свои пожелания.
- Впишите имя и номер телефона Вашего раввина, а также расположение Вашего участка на кладбище. Если Вы уже заплатили за участок, приложите квитанцию или укажите, где её можно легко найти.
- Держите эти пожелания отдельно от завещания. Нужно, чтобы их было легко найти среди Ваших важных бумаг.
- Обсудите Ваши пожелания с родственниками, друзьями или с Вашим раввином.

Все эти шаги помогут в выполнении наших пожеланий, чтобы погребение соответствовало нашим убеждениям, и чтобы мы покоились рядом с близкими, друзьями или членами нашей общины.

HFBA помогает

• В сентябре прошлого года в Еврейское Благотворительное Похоронное Бюро (HFBA) позвонили из городского морга по поводу некоего Виктора С*, который скончался в возрасте 46-и лет от передозировки наркотиков. Домовладелец усопшего сообщил нам, что его жилец был евреем, носил кипу, и что у него была мезуза на косяке двери. Когда HFBA связалось с офисом городского администратора, там сказали, что им известно об этом случае, и что номер социального страхования усопшего совпадает с номерами двух человек - некоей Сабрины С* и Виктора С*. Тогда наши сотрудники сообразили, что Виктор был трансгендером. Поскольку было установлено, что он был евреем, Виктор имел право на погребение по еврейскому обряду. Его похоронили на принадлежащем HFBA кладбище. Члены нашего миньяна добровольцев, пришедших на другие похороны, остались и прочитали кадиш по Виктору. Никто из друзей или родственников не присутствовал.

Как мы писали в прошлых номерах, козы были привезены на наше историческое кладбище Сильвер Лейк в 2016-м и 2017-м годах весной и летом, чтобы уничтожить заросли ядовитого плюща и других нежелательных растений. А недавно на наше действующее кладбище Маунт Ричмонд стали чаще чем обычно наведываться стаи диких гусей. Чтобы ограничить число этих нежеланных гостей, HFBA связалось с «Гусиной Полицией» – частной компанией, которая привозит специально обученных собак для отпугивания диких гусей. Silver Lake Cemetery Preservation Project

HFBA's historic Silver Lake Cemetery, which was founded in 1892, and is the beneficiary of a New York State Historic Preservation Grant, is currently undergoing the challenging process of conservation and repair. Over one hundred wild trees which were damaging the site have been removed. The original stone walls enclosing the cemetery are being stabilized. And low-lying areas in the cemetery, which has a sloping topography causing rain water to collect at a central point, are being filled. In addition, a new drainage system is being installed to channel excess water outside the cemetery.

We expect this first phase of the preservation work to be finished by early summer.

Geese Police

Chesed readers seem to enjoy stories about animals and now we have another to report! As described in previous editions of this newsletter, goats were welcomed to Silver Lake Cemetery in the spring and summer of 2016 and 2017 to eat poison ivy and other unwanted vegetation.

We are now being visited by flocks of wild geese in Mount Richmond Cemetery. To control these unwanted guests, HFBA has contracted with the Geese Police, who bring trained dogs to the cemetery to chase away the geese. Happily, this method has been very effective in reducing the number of geese and their waste in the cemetery.



At the beginning of the seder, we invite "all who are hungry, come and eat" and "all who are needy, come and participate in the Passover ritual." The message of caring for those whose basic needs are not being met, including that of companionship, is relevant throughout the year. With your help, HFBA extends that *chesed* to poor and isolated Jews upon their deaths as well.

THE HEBREW FREE BURIAL ASSOCIATION was formed in 1888 on Manhattan's Lower East Side by a group of philanthropic and communityminded Jews who were committed to burying their indigent dead according to Jewish tradition, rather than having them buried in a mass grave in city cemetery. Since its inception HFBA has

interred over 65,000 Jews in its two cemeteries. HFBA is also committed to retrieving the identities of those interred and is attempting to provide a gravestone for each unmarked grave.
